The Sharing of personal information with third parties

Constructor Group will not share your personal information collected from this Website with an unrelated third party without your permission, except as otherwise provided in this Privacy Policy.

In the ordinary course of business, if you grant us permission, we will share some personal information with companies that we hire to perform services or functions on our behalf. For example, we may use different vendors or suppliers to ship you products that you order on our Website. In these cases, we provide the vendor

with information to process your order such as your name and mailing address. In all cases in which we share your personal information with a third party, we will not authorise them to keep, disclose or use your information with others except for the purpose of providing the services we asked them to provide.

We will not sell, exchange or publish your personal information, except in conjunction with a corporate sale, merger, dissolution, or acquisition. You have at all times the right to access to, rectification of and objection to the use of the personal data.

We may be legally compelled to release your personal information in response to a court order, search warrant, law or regulation.
